Congratulations on your appointment. We look forward to your joining AGT and being part of the Corporate Communications Team.

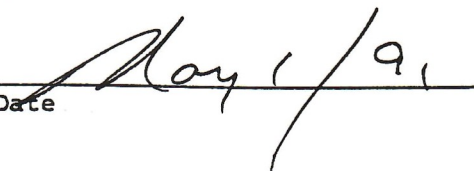

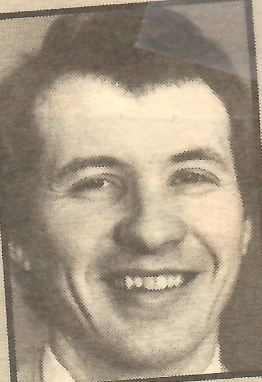
